### MEETING MINUTES

April 16, 2019 Regular Meeting

The Grady County Board of Commissioners met on April 16, 2019 at 6:00 pm for the regular scheduled meeting. Chair LaFaye Copeland, Vice-Chair Keith Moye, Commissioners June Knight, Ray Prince, Phillip Drew, County Administrator Buddy Johnson, County Clerk John White, Finance Director Holly Murkerson, and Lake Authority Director Mike Binion were in attendance.

The meeting was called to order at 6:00 PM by Chair Copeland. Mrs. Copeland asked Deputy Jackson to open the meeting with prayer and the pledge of allegiance.

The agenda for the meeting was approved on a motion by Mr. Prince and second by Mr. Drew.

- B. Motion by Mr. Moye, second by Mrs. Knight to formally approve the waiving of fees for building permits related to Hurricane Michael and the ending of such waivers effective 5/31/2019. To date, this has allowed \$17,680.00 to be put to work in the community to help citizens recover. The motion was approved.
- C. Administrator Johnson asked that the request to increase the budget for the Office of the District Attorney South Georgia Circuit to \$4,692.08/month be tabled until budget time. Mr. Johnson stated that he had spoken to DA Mulholland and the DA stated it could be added in the new budget to start in January. The commissioners agreed to table the action.

#### **NEW/UNFINISHED BUSINESS**

Mr. Johnson reported that a new Face Book page for the Grady County Lake Authority will be created. He stated it will be an information only page and comments will not be allowed.

Mr. Moye stated Beck Branch neighbors are happy with the new dump site. Next up will be next to the sheriff's Office.

Capital Assets Training has been completed by all department heads and the County Administrator.

Jackie Robinson Boys and Girls Club will be recognized on the Braves broadcast tonight.

Mrs. Knight stated she received a letter from Raymond Stokes about using solar panel lights on the docks at the lake. Mr. Binion stated that the lights have been ordered and received. They will be installed as soon as Mr. Harrison is able to get to them on the work list.

Mrs. Copeland invited everyone to the Easter Egg drop at the airport on Saturday from 4:00 pm to 5:30 pm.
